

Amerispa_30 years dedicated to wellness Contest Rules & Regulations

The **30 years dedicated to wellness** contest (hereinafter "**contest**") is being organized by Amerispa Inc. (hereinafter "**Amerispa**"). The contest begins on May 27, 2024 at 09:00 a.m. Eastern Time ("**EDT**") and ends on June 17, 2024 at 11:59 p.m. Eastern Time ("**EDT**") (the "**contest period**").

ELIGIBILITY

The Contest is open to Canadian residents who have reached the age of majority in their province of residence at the Contest opening date. Employees, agents and representatives of Amerispa, its subsidiaries, its advertising and promotion agencies and its partners, as well as members of their immediate families (brothers, sisters, children, mother and father), their lawful or common-law spouse and any person domiciled with these employees, representatives and agents, are not eligible.

To participate in the contest, the participant must use one of the participation forms available on the web pages mentioned above and enter all the requested information. **One entry per person** using one of the two links for the duration of the contest.

DRAW

A random draw will take place on June 18, 2024 at 1:00 p.m. (EDT), conducted by a representative from Amerispa, at the head office located at 100 Boulevard de la Marine, Suite 2A, in Varennes, among all eligible entries received since the beginning of the contest.

The 30 first participants randomly selected who have completed the participation form will be declared winners, subject to fulfilling all the conditions described in these rules and will be awarded one of the following prizes.

PRIZE DESCRIPTION

Each prize must be accepted as awarded and cannot be transferred, refunded, sold, or exchanged for cash or otherwise.

3 winners will each receive a relaxation getaway for 2 people at one of our affiliated hotels (including one night in a double occupancy room, a \$200 credit for dinner, breakfast, and two (2) 50-minute relaxation massages), each with an approximate value of \$1400. The choice of the hotel will be made from the list of affiliated hotels with the Amerispa representative, based on availability on the desired dates. This stay must be used within one year of receiving the prize.

27 winners will each receive a Serenity Package for 1 person at one of our Amerispa or Moment Spa centres (including a Relaxation Massage, a Leg Comfort Treatment and an access to water facilities.), each with an approximate value of \$300. This package must be used within one year of receiving the prize.

The prize only includes what is specifically described herein, and no other allowances are granted. The winner and accompanying person (for the relaxation getaway), if applicable, must bear the following expenses, including but not limited to:

- Transportation and parking;
- Amounts for treatments exceeding the allocated amount, if applicable;
- Any personal expenses.

PRIZE AWARD

The winners will be notified by email within 5 days following the draw. The winners must confirm the claiming of their prize according to Amerispa's instructions within a maximum of seventy-two (72) hours from the date they were contacted.

In the event that a winner cannot be reached within seventy-two (72) hours following the first attempt of contact, or if the person refuses the prize or fails to return the declaration and release form as per the terms indicated below, they will automatically forfeit their prize, and Amerispa may, at its sole discretion, designate another winner.

Before being declared a winner, each of the winners must sign a declaration and release form, confirming, among other things:

- he/she has read the contest rules and regulations and complies completely;
- he/she accepts the prize as awarded;

To be declared a winner, the selected participant must have completed the declaration and release form.
